## Capabilities

- **Account Validation**
  - Confirms ABA/DDA numbers, validates linked accounts, and supports tokenization for future transactions
- **Transaction Management**
  - Cancel or refund items after submission
  - Manage returns with automated matching, email alerts, and online reporting
- **Settlement Tools**
  - Split funds by dollar or percentage before settlement for faster funding i.e. platform fee to ISV/gateway
- **Risk & Exception Handling**
  - Monitor portfolios and transactions in real time; no hard limits for review on flagged items without hard limits
- **Virtual Terminal**
  - Supports one-time, recurring, future-dated, or installment payments
- **Secure Data**
  - Tokenizes account details for safe storage and repeat transactions
  - No need to store ABA/DDA on platform

## How it Works

- **Payments submitted via:**
  - Direct API integration
  - Gateway integration
  - ISV integration
  - Virtual terminal
- **Cutoff Times**
  - Same-Day ACH: 11AM or 2PM CT
  - Standard ACH: 8PM CT

### Settlement Process

Funds are deposited to designated accounts the next processing day.

### Example:

- Submitted Monday before 8PM CT
- Clears Monday night
- Settles Tuesday → in merchant's bank Wednesday

**Weekend transactions** settle the next business day.

\*Faster settlement options are available.
